Monthly installments are billed a month in advance. Annual memberships are based on 12 months and will automatically renew each year. Please review the by-laws for membership termination information. Termination requests must be submitted in writing with 30 days' notice.

If payment is made for the full year, your membership will roll into the monthly installment plan at the expiration of your term. You may continue to pay for the full year if you choose. Payment of the initiation fee and first month membership installment must be submitted with your application. Initiation fee is non-refundable and is only required for new applications. Applications are subject to review and approval by the Board of Directors. The membership is not active until notified by the Board of Directors of application approval. Applicants are not permitted to use any of the club's facilities, programs or events until notified of the Board's acceptance of the membership.
